FOURTEENTH REPORT OF THE TRUSTEE OF THE MUNICIPALITY OF DANZIG 5%
(ORIGINALLY 7%) MORTGAGE LOAN OF 1925¹*(covering the period from March 15th, 1938, to March 15th, 1939.)*

In accordance with the Council resolution of March 14th, 1925,² I have the honour to submit to the Council of the League of Nations the Trustee's annual report concerning the Municipality of Danzig 5% (originally 7%) Mortgage Loan of 1925, covering the period from March 15th, 1938, to March 15th, 1939.

On March 15th, 1938, the balance of the proceeds of the loan standing to the credit of the Trustee's Account amounted to	68	1	6
blocked for the redemption of the then still outstanding balance of \$324 bonds of the Mortgage Dollar Loan. During the financial year 1938/39, \$39 bonds of the said loan were repaid, in which connection the countervalue of that amount, calculated at the agreed rate of exchange of \$4.76 to the £ sterling, viz	8	3	11
was released. There consequently now remains in the Trustee's Account an amount of	59	17	7
blocked for redemption of the still outstanding balance of \$285 of such bonds.			

According to the Trustee's thirteenth annual report, the Municipality of Danzig had, on March 15th, 1938, still the right to require the release of pledged property—without providing
