

**906. Supervisory Commission Appointment of two Substitute Members.**

With reference to Minute 884, the Council decided to appoint M. H. ZAHLE (Denmark) and M. Parra PEREZ (Venezuela) to serve as substitute members on the Supervisory Commission until the next Assembly

**907 Representation of the League at the Centenary of Pasteur.**

The SECRETARY-GENERAL reminded the Council that it had decided<sup>1</sup> that it should be represented on the occasion of the fêtes held on the centenary of Pasteur, which would be celebrated at Strasburg on May 31st and June 1st, 1923.

On the proposal of the PRESIDENT, the Council asked M. Adatçı, Rapporteur for health questions, to act as its representative.

*M. Adatçı agreed to this proposal.*

**908. Albania Contract of the Financial Adviser for Albania.**

The Council approved the contract of M. Hunger, Financial Adviser to the Albanian Government.

**909. Composition of the Health Committee.**

On the proposal of M. ADATCI, the Council appointed Dr. Uchuno as a permanent member of the Health Committee in place of Dr. Miyajima, who had resigned.

FOURTH MEETING (PUBLIC)

*held at Geneva on Thursday, April 19th, 1923, at 10.30 a.m.*

Present. All the representatives of the Members of the Council, and the Secretary-General.

M. Askenazy representative of Poland, M. Sahn, representative of the Free City of Danzig, and M. MacDonnell, High Commissioner of the League at Danzig, came to the Council table.

**910. Free City of Danzig The Financial Situation of the Free City**

M. QUIÑONES DE LEÓN read a report on the financial position of the Free City (Annex 490) and submitted the following resolution

“ (1) The Secretary-General is requested to continue the negotiations with the Reparation Commission and the Conference of Ambassadors concerning the financial situation of the Free City of Danzig, and to communicate to these bodies a copy of a note from the President of the Danzig Senate dated April 17th, 1923, with the request that they will communicate their observations on the proposals adopted by the Financial Committee of the League on January 31st, 1923, at their very earliest convenience, and, if possible, before the end of the present Council session.

“ (2) The Secretary-General is requested to continue to keep the Financial Committee of the League and the Danzig Government, as well as the Reparation Commission and the Conference of Ambassadors, informed of further developments in the question of the financial situation of the Free City ”

*The resolution was adopted.*

**911. Free City of Danzig Leasing of Property by the Danzig Harbour Board.**

M. QUIÑONES DE LEON read a report on the leasing of property by the Danzig Harbour Board (Annex 491) and submitted the following resolution

“ The Council of the League of Nations notes and confirms the agreement between the President of the Senate of the Free City of Danzig and the representative of the Polish Republic dated April 16th, 1923, with regard to the decision of the High Commissioner of the League of Nations in Danzig of October 27th, 1922, concerning the leasing of property by the Danzig Harbour Board.”

*The resolution was adopted.*

M. ASKENAZY, representative of Poland, stated that he confirmed this agreement.

The PRESIDENT, on behalf of the Council, expressed gratification at the solution of a difficult problem.
